**ORDER RESTRICTING REPORTING OF THE IDENTITY OF A WITNESS**

**UPON ESTABLISHMENT** by Instrument dated the 20<sup>th</sup> day of June 2024 (S.I. 304 of 2024) of a Tribunal of Inquiry into Issues Relating to the Complaints Processes in the Defence Forces in respect of Complaints of Abuse and Complaints of Hazardous Chemicals and to the Culture Surrounding the Making of Complaints of Abuse (hereinafter '**the Tribunal**') charged with investigating the matters provided for in its Terms of Reference from the 1<sup>st</sup> day of January 1983 to the 20<sup>th</sup> day of June 2024; and

**WHEREAS** the Oireachtas has determined that the matters which the Tribunal has been charged with investigating are definite matters of urgent public importance; and

**WHEREAS** the Tribunal has received an application, in writing, from a witness ('the applicant') who seeks to give his evidence otherwise than fully in public; and

**WHEREAS** the Tribunal considers that the evidence of the applicant is necessary for and relevant to its consideration of the matters that are set out in the Tribunal's Terms of Reference (i) to (v) inclusive; and

**BEARING IN MIND** the Notice published by the Tribunal on 27<sup>th</sup> day of May 2026 in respect of applications for evidence to be heard otherwise than, fully, in public; and

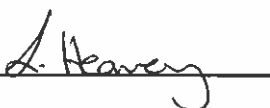
**RECALLING** that section 1(1) of the Tribunals of Inquiry (Evidence) Acts 1921-2011 vests in the Tribunal all powers, rights, and privileges as are vested in the High Court in respect of certain matters including the examination of witnesses; and

**FURTHER RECALLING** that pursuant to Section 4 of the Tribunals of Inquiry (Evidence) (Amendment) Act 1979 the Tribunal may make such orders as it considers necessary for the purposes of its functions; and

**THE TRIBUNAL BEING SATISFIED** that it is both necessary and proportionate for it to make the following Order;

**HEREBY ORDERS** that no report of the proceedings of the Tribunal that contains material or information likely to lead members of the public to identify the witness referred to by the pseudonym 'Mr R' shall be published in a written publication available to the public or be broadcast in any format by members of the media or by media organisations or by any other person or persons.

This Order is made without prejudice to the powers conferred upon the Tribunal by section 2(2)(a) of the Tribunals of Inquiry (Evidence) Acts 1921-2011.
